

Dear Friends: September 13, 2023

This letter is to update our immersion programs for top U.S. and Chinese law students. To help educate these future leaders, hundreds of current leaders have given their time and/or support letters (e.g., Boehner, Carson, Chu, Francisco, Kerry, Hoyer, Pai, Pelosi, Pence, Sanders). Special efforts have come from Senators Durbin, Hatch, and Inouye; Secretary LaHood; and Justices Alito and Jackson. Such investments in future leaders can support future U.S.-China relations. <u>U.S. Program</u>. Each summer since 2008, we have hosted small groups of bilingual Chinese law students for four weeks in Washington, DC. We selected these 82 *Chinese fellows* from China's top schools. During their busy month in DC, they attended legislative and judicial proceedings and met with U.S. government officials, typically six meetings per day. These meetings included over 900 members and staff of Congress, over 200 administration officials, and over 130 judges. When not in meetings, they visited our museums and landmarks, joined our cultural and social events (e.g., July 4<sup>th</sup> fireworks, Nats games, backyard BBQs), and gained lifelong impressions and friends. <u>China Program</u>. Each summer since 2016, we have sent small groups of bilingual U.S. law students to China for two weeks. We selected these 37 *American fellows* from Columbia, Cornell, Duke, Georgetown, GWU, Michigan, Penn, UVA, and Yale. Please visit www.usasiainstitute.org/ruleoflaw/chinaprogram.

**Program History**. The idea for these programs arose during my service as chief of staff for the Small Business Committee and the U.S.-China Interparliamentary Exchange in the U.S. House of Representatives from 2002-2007. During our many delegations to China, every meeting with college students managed to impress everyone involved. The idea grew after I moved to China in 2007 and began teaching part-time at Chinese law schools. The program started with one of my students in 2008 and USAI adopted the program in 2011. In 2014, I moved back to the U.S. where I have continued to guide the program as a USAI advisor.

**Program Impact**. Fellows from both programs now serve in academia, government, NGOs, corporations, and law firms. See the attached alumni letters, and these approved quotes:

# Special Host from the Judicial Branch: Supreme Court Justice Samuel Alito

Three members of the Supreme Court have participated, including Justice Jackson (4X), Justice Kavanaugh (3X), and Justice Alito (2X). Justices Jackson and Kavanaugh participated in their prior roles on lower courts.



On June 27, 2016, we viewed the Court's final session then met with Justice Alito for 30 minutes of Q&A.

We have met with about half of all federal judges based in D.C., often after viewing one of their proceedings. The D.C. Circuit and District judges who have joined us three or more times include: John Bates, Jeb Boasberg, Tanya Chutkan, Thomas Griffith, Ellen Segal Huvelle, Amy Berman Jackson, Ketanji Brown Jackson, Brett Kavanaugh, Timothy Kelly, Royce Lamberth, Amit Mehta, Patricia Millett, Randolph Moss, David Sentelle, Sri Srinivasan, Emmet Sullivan, David Tatel, and Reggie Walton. We are especially grateful for the participation of Judges Lamberth (10X), Huvelle (9X), Srinivasan (8X), Boasberg (8X), and Sullivan (7X). The Federal Circuit judges who have joined us at least twice include: Chief Judge Sharon Prost and Judges Timothy Dyk and Richard Linn.

The D.C. Superior Court judges who have joined us at least twice include: Chief Judge Robert Morin (8X) and Judges Gerald Fisher (8X), Ann Keary (7X), Russell Canan (5X), and Henry Greene (2X). Please see host list.

Our students come from China's top schools: Beijing/Peking University (PKU), Tsinghua, and Shanghai Jiaotong. About half each summer come from PKU's School of Transnational Law, whose four-year graduate law program combines a Juris Doctor in American law with a Juris Master in Chinese law. Many U.S. judges have taught there.

This program began as an experiment in 2008. In his spare time, Matthew guest-lectured at East China University of Political Science & Law (ECUPL) with his friend, Prof. Sun Chao, who was the top official in Minhang District in central Shanghai. They taught U.S.-style law courses to bilingual ECUPL students at ECUPL, Minhang District Courthouse, Matthew's home, and elsewhere. See pics below. Many of their students expressed great interest in the U.S. legal system. They selected one to visit D.C. in the summer of 2008. The program grew from there.
